The cost of education today is a substantial investment, one which is likely to be your second largest next to a home purchase. If you are hurt or become ill and cannot complete the term, you stand to lose thousands of dollars.

While most colleges provide partial refunds for withdrawals, they are limited and usually effective only when you withdraw early in the term. This Plan dramatically enhances the college refund schedule and provides more generous refunds throughout the entire term.

The Tuition Refund Plan will alleviate if not eliminate your financial loss. The Plan will return your tuition and allow you to re-enter college when a term must be repeated. It will provide funds which can reduce your loan obligations under government or private loan programs.

If you withdraw from classes because of a personal injury or sickness, this Plan will return . . .

- 100% of your insured term tuition, room and board, fees, or
- 60% of your insured term tuition, room and board, fees if the withdrawal results from a psychological/emotional condition

The refund can assist you greatly by giving you . . .

- Money that can ease your loan obligations
- Money that can allow you to continue your education without increasing your costs

Every student or parent for whom the loss of a term's fee would represent a significant financial hardship should take advantage of the Tuition Refund Plan.

BENEFITS:

- **Injury & Sickness Withdrawals**

100% of the insured term tuition, fees, room and board, less any refund or credit due you from the University, will be refunded provided your physical condition is certified by a licensed physician and forces you to completely withdraw from classes for the balance of the term.

- **Psychological/Emotional Withdrawals**

60% of the insured term tuition, fees, room and board, less any refund or credit due you from the University, will be refunded provided you are confined in a hospital for seven consecutive days during the term and have completely withdrawn from classes for a condition whose diagnosis is found in the DSM-IV Manual.

In both cases above, a "complete withdrawal" is required. This means you have given written notice that because of your injury or sickness you will not be able to complete the term and you will not receive any academic credit. A written statement from your doctor certifying the injury or sickness and University verification will be required.

CONDITIONS OF COVERAGE:

The insurance may be purchased to cover tuition, fees, room and board. Off campus room, meals, books, or fraternity/sorority charges, or incidental charges cannot be insured.

Your protection covers a full term from the opening to closing date. This coverage refunds on a term basis only. Your premium covers a full year, but if for any reason you do not return for subsequent terms, please notify us and any unused premium will be refunded to you. If you start classes after opening date, you can still enroll in the Plan if your application is postmarked before your first class day. No applications can be accepted if mailed after you start classes.

EXCLUSIONS:

Note that the Plan does not cover the following:

- war or any act of war, declared or undeclared
- terrorism
- the use of any drug, narcotic or agent which is similarly classed or has similar effects (excepting when it is prescribed by a doctor)
- taking part in a riot
- failure to attend classes for any reason other than injury or sickness
- withdrawal when the student receives credit for an incomplete term
- suicide or intentional self-inflicted injury or sickness
- nuclear reaction, nuclear radiation or radioactive contamination.

CLAIMS:

Claim forms with full instructions are available at the Student Accounts office. Claims should be reported within 30 days from occurrence or as soon as it is reasonably possible. You should arrange for the completion of the claim form. Benefit payment is made to the University to be credited to the student's account. Benefits not required to settle the student account will be refunded to you through the University.

All Psychological/Emotional withdrawals will be classified in accordance with the American Psychiatric Association's Diagnostic and Statistical Manual-DSM-IV.
